## Program Spotlight: Sexual Assault Response Team

SART stands for Sexual Assault Response Team. It is a multidisciplinary team made up of victim advocates, law enforcement, prosecution, hospital staff, other community partners, and sexual assault advocates. The SART develops a protocol for dispatching sexual assault advocates to a scene when someone reports a sexual assault and provide advocacy and accompaniment in this process.

The goal of the SART team is to create policy and protocol that aligns with the needs of each individual partner while maintaining a trauma informed, victim centered, and best practices approach to handling sexual assault cases in Jackson County. Currently, we are in the process of rebuilding the Sexual Assault Nurse Examiner (SANE) program at Henry Ford Jackson Hospital. In the meantime, we have developed a response protocol and established safe referrals to clients as they navigate their process.

The SART team is important because it provides privacy, confidentiality, and choice to the survivor when they are deciding who they want to disclose to and what follow up services they want to pursue by connecting the survivor with an advocate early on in the process.
